Background review will be held on January 22, and Interviews will be conducted in Springfield on February 4-5, 2025. A total of 192 backgrounds were initiated for Cadet Class 151 and 152 which are set to begin in June. Background review will be held on March 13, and Interviews will be conducted in Springfield on March 25-26, 2025.

Executive Director Emily Fox updated the Board on the 2025 Promotional Process. In 2025, the Board will be testing to the rank of Lieutenant and Captain. Promotional testing will be conducted the week of September 15-19, at the Merit Board office in Springfield. Test development will begin within the next few weeks, and the reading lists are set to be published for candidates by April 1, 2025.
