#### John Baker:

At the Merit Board hearing his commanding officer testified about his integrity and what he has done to make a mends. ### Anthony McClure:

"I am going to try first of all I want to apologize for my wife for publicly embarrassing her, apologize to you guys for you to having to even hear this and apologize to my friends for the things that I've done and I love my job and I just ask for your mercy"

## Missy McClure:

Thank you for your time today it's been two years since this whole ordeal began and tony and I have had some major obstacles in our marriage but I am happy to tell you that we celebrated our 25th wedding anniversary two weeks ago and I'm in it for the long hall. I believe in our marriage I believe in my husband and I'm a forgiving, understanding person and with that Tony and I have been able to put the past behind us and to move forward. It has been difficult, but I truly believe that my husband has done everything above and beyond to compensate what he has done. he is a dedicated hard working man an looking at the scope of his 20 years with ISP is a true accurate portrait of my husband; I truly believe with all my hear that Tony is a good man who made a bad choice plain and simple, and I would just ask for your consideration.
